LOW WATER CROSSING

STATUS OPEN: Site is open, typical stream crossing hazards exist requiring risk assessment prior to crossing.

STATUS INCREASED RISK: Site is open, increased hazards exist requiring risk assessment. Tactical crossings may be open, but increased hazards may result in commanders/vehicle commanders deciding not to cross based on the results of their risk assessment.

STATUS CLOSED: Site is closed, significant increased hazards exist.

Note 1: When the Low Water Crossing report status turns **CLOSED**, immediately notify the MSCs and PAO telephonically and email the updated Low Water Crossings report.

Note 2: Once the determination has been made to close any hard stand and bridge water crossing sites on Fort Hood Range Support Operations / DES will contact the IOC. The IOC will in turn contact all MSCs and PAO on call IOT inform the community of the change in the cantonment LWC status.

Note 3: Once weather has cleared, Range Support Operations / DES will assess the possibility of re-opening the crossing sites. Range Support Operations / DES will determine if and when tactical, hard stand and bridge crossing sites should be re-opened based on weather and safety conditions. Once the determination has been made to re-open the sites, the IOC will be notified. IOC will in turn notify all MSCs and PAO of the change and up-date the LWC report.
